RESOLUTION NO. 22-23/16
APPROVAL OF PIGGYBACK CONTRACTS AND COOPERATIVE PURCHASING
AGREEMENTS FOR 2023-2024 FISCAL YEAR

WHEREAS, the Board of Trustees (the “Board”) of the Rosemead School District (the “District”) has determined that a true and very real need exists for the utilization of Piggyback Contracts and other Cooperative Purchasing Agreements for the 2023-2024 Fiscal Year; and

WHEREAS, the Board of Trustees of a school district may under Section 20118 of the California Public Contract Code, without advertising for bids, if the Board has determined it to be in the best interest of the District, authorize by contract, lease, requisition or purchase order, any public corporation or agency to lease data- processing equipment, purchase materials, supplies, equipment, automotive vehicles, tractors, services and other personal property for the District in the manner in which the public corporation is authorized by law to lease or purchase; and

WHEREAS, the Board of Trustees of a school district, under Sections 10298 and 10299 of the California Public Contract Code may, without competitive bidding, contract with suppliers that have been awarded contracts, master agreements, multiple award schedules, cooperative agreements or other types of agreements, including agreements with entities outside the state or other agreements that leverage the state’s buying power, for acquisitions of information technology, goods and hereby acknowledges the following:

WHEREAS, the Board of Trustees of the District has determined that it is in the best interest of the District to authorize procurement utilizing Piggyback Contracts and other Cooperative Purchasing Agreements that have been evaluated and approved for use in the 2023-2024 Fiscal Year; and

WHEREAS, the Board of Trustees agrees that the validity of Piggyback Contracts and other Cooperative Purchasing Agreements would best be determined by the Assistant Superintendent of Administrative Services, or his/her designee.

NOW, THEREFORE, the Board of Trustees hereby finds, determines, declares and resolves as follows:

Section 1. All of the recitals set forth above are true and correct and the Board so finds and determines.

Section 2. The Board hereby finds and determines the utilization of Piggyback Contracts and other Cooperative Purchasing Agreements, pursuant to Public Contract Code Sections 10298, 10299 and 20118 to be in the best interest of the District since these contracts and agreements have already been through a competitive process.

Section 3. The Board hereby delegates to the Assistant Superintendent of Administrative Services, or his/her designee the authority to evaluate and determine the validity of any and all Piggyback Contracts or other Cooperative Purchasing Agreements available to the District.

Section 4. The Superintendent or Superintendent's designee is hereby authorized and directed to do any and all things, and to execute and deliver any and all documents which they may, in consultation with legal counsel, deem necessary or advisable in order to consummate this transaction and otherwise carry out, give effect to and comply with the terms and intent of this Resolution.

Section 5. This Resolution shall be effective as of the date of its adoption.

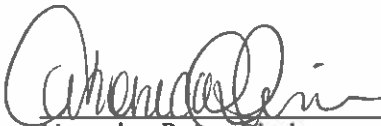
