**IN SUPPORT OF THE PASADENA CITY COLLEGE (PCC) – ROSEMEAD CAMPUS**

**WHEREAS**, the Rosemead School District recognizes that the El Monte Union High School District owned facility located at 4105 N. Rosemead Blvd., in Rosemead, has been leased out to Pasadena City College (PCC), which established a satellite location “PCC Rosemead campus” in 2013; and

**WHEREAS**, the Rosemead School District Board of Trustees supports opportunities for higher education immediately in the community for all residents; and

**WHEREAS**, the Rosemead School District recognizes that higher education first begins with the individual who seeks further opportunities; and

**WHEREAS**, the PCC Rosemead campus was established to provide an educational site to local and nearby residents to continue its commitment of providing access to higher education for the diverse communities within PCC’s local service area; and

**WHEREAS**, the PCC Rosemead campus has brought additional educational opportunities and options to the local residents of Rosemead and surrounding cities, thus ensuring that a viable college option is within reach for our alumni in their immediate community; and

**WHEREAS**, the Pasadena City College Rosemead Campus:

- provides an easily accessible local college option for residents,
- allows for a small, intimate setting for students who may need a smaller group setting,
- easy access to faculty members for one-on-one support as a result of a smaller student body,
- supports the completion of General Education requirements for an AA or AS degree,
- prepares students to transfer to a 4-year college or university,
- allows students to complete requirements for a degree within 5 academic programs,
- allows an opportunity to current local high school students looking to enroll concurrently for credit, and
- provides continuing education opportunities for adults, such as English as a Second Language, Adult Basic Education, Parent Education classes, as well as other valuable supports;

**NOW, THEREFORE, BE IT RESOLVED**, that the Board of Trustees of the Rosemead School District recognizes the immediate needs of its families for higher education.

**BE IT FURTHER RESOLVED**, that the Rosemead School District Board of Trustees fully supports maintaining the Pasadena City College Rosemead campus in its current location at 4105 N. Rosemead Blvd., in Rosemead, as it provides an important educational opportunity to our students in the City of Rosemead and surrounding communities. The Board of Trustees also recognizes that the relocation of the PCC Rosemead campus would be a detrimental loss to Rosemead and surrounding communities and the individuals who rely on the enriching


