### **Rosemead School District is Accepting Applications to Fill a Vacant Seat on the Board of Trustees**

**Rosemead, California:** Due to the death of Randall Cantrell, Board member, the Rosemead School District currently has a vacancy on its Board of Trustees, for the remainder of the term which expires on December 4, 2020. At the Regular Board Meeting of May 4, 2017, the Board announced the process to fill the vacancy by a provisional appointment from among qualified applicants.

The District is requesting all those interested in serving on the school board submit an application. Applications are available on the District website, <http://www.rosemead.k12.ca.us/> and at the District Office, 3907 Rosemead Boulevard Rosemead, CA 91770.

To be eligible to apply for appointment to the Board of Trustees, an individual must be at least 18 years old, be a resident of the Rosemead School District, be a registered voter in the State of California, and not be disqualified from holding civil office by the constitution or any law of the State of California.

*The provisional appointee will hold office only until the District's next regular election which will be held on November 6, 2018, at which time, if the appointee intends to serve for the remainder of former trustee Cantrell's term, i.e., December 4, 2020, he or she will need to run for the remainder of the term of office at the November 6, 2018 election.*

An employee of the Rosemead School District may not be sworn into office as an elected or appointed member of the Board, unless he or she resigns as an employee. If the employee does not resign, the employment will automatically terminate upon being sworn into office.
