AGENDA ITEMS

- 1. Minutes Review/Approval
 - a. October 3, 2013

This agenda item was added to the agenda via the following vote: Mr. Mascorro moved and Mrs. Dundas seconded to add the Review and Approval of the October 3, 2013 Minutes to the agenda. The motion was unanimously approved.

Mr. Harmon moved and Mr. Dundas seconded to approve the October 3, 2013 minutes. The motion was approved with a 3-0 vote, with an abstention by Mr. Mascorro because he was not present during the meeting.

2. Review of 2012-2013 Audit Report: Hadley Hui, Moss, Levy & Hartzheim, LLP Mr. Hui reviewed the 2011, 2012, and 2013 Financial and Performance Audits. Mr. Hui reported that for 2011, 2012, and 2013 the firm issued a qualified opinion, the highest rating. The ending fund balances for each year were as follows: 2011 \$13,449,054; 2012 \$13,401,755; and 2013 \$8,224,762.

3. Project Updates

Mrs. Romero provided an update to the committee members as follows:

- District Office:
 - o Voluntary structural retrofitting
 - o Redo of the restrooms to meet handicap restroom requirements
 - o Installation of catwalks in the attic for maintenance & operations staff
 - o Thanked the District Office staff for their patience through construction
 - o Change orders will be forthcoming to address items that will update the building structure
 - o Air conditioning units will include both new units and wall units
 - o New fence on Rosemead Blvd.
- At School sites:
 - o Some fire alarms are beginning to fail, roofing and windows still need to be considered for replacement.
 - o Room 19 at Janson is a prime example of a remodeled room.
- Savannah:
 - o Relocatables needing replacement
- Muscatel:
 - o Two phase project including the Multi-Purpose Room and Room 5.
- Shuey:
 - o This will be the next construction project because they need additional classes, next year.
 - o 3 relocatables are going to be recycled to Shuey as office space, meeting rooms, or storage from Savannah.
