CALL TO ORDER

PUBLIC COMMENTS

There were none.

INTRODUCTIONS

Members of the Citizens' Bond Oversight Committee and guests introduced themselves. Those present included: Maria-Elena Romero, Armida Carreon, Hadley Hui, and Lee Wang.

AGENDA ITEMS

Mr. Harmon moved and Mr. Dundas seconded to approve the September 3, 2015 and March 3, 2016 minutes. The motion was approved with a 6-0 vote.

2. Review of Future Meeting Schedule (Time: 5:00 p.m./Location: TBD): Thursday, September 1, 2016; Thursday, March 2, 2017; and Thursday, September 7, 2017
The committee members reviewed the future meeting schedule.

The following agenda item was added to the agenda via the following vote: Mrs. Dundas moved and Mr. Dundas seconded to add the Review and Approval of 2015 Bond Audit. The motion was unanimously approved.

3. Review and Approval of 2015 Bond Audit: Hadley Hui, Moss, Levy & Hartzheim, LLP

Mr. Hui reviewed the 2015 Financial and Performance Audits. Mr. Hui reported that for 2015 the firm issued a qualified opinion, the highest rating. The ending fund balance for 2015 was as follows: \$2,349,955. Mr. Hui reviewed the audit process with the members and explained that it takes approximately 2 ½ weeks with a crew of auditors requesting documentation. Mr. Hui confirmed that there were no findings in the 2015 audit.

Mrs. Romero shared with the committee that next time the District issues it will be against Measure RR. She further explained that Measure O was authorized for \$30 million but we will not issue any more for about another 15 years, with approximately \$17 million used.

4. Project Updates

Mrs. Romero provided an update to the committee members as follows:

- Shuey Multi-Purpose Room:
 - Kitchen and cafeteria will be relocated to classrooms
 - o Construction project will begin in April, 2016; 4-5 months
- Shuey portables at the front of the school 4 classrooms and restrooms, 1 will house preschool
- Roofing Savannah and Shuey:
 - We will be bidding and awarding roofing work for Shuey and Savannah this summer
- Permanent classrooms at Shuey will be a separate project
- Summer 2017 most of the relocatables 12 will be taken out, ground will be leveled
- Design and bidding fire alarms Shuey will be done first
- When funding was reduced some items were eliminated, such as windows. We've given the architects direction in some items for them to start planning
 - o A member suggested researching pricing on security cameras

5. Review of Current Membership and Terms

The District will request the following information from Legal Counsel: 1) see if the District can extend terms for 3rd term members: Mr. Dundas, Mrs. Dundas, Mrs. Dundas, Mrs. Harmon, and Mr. Bouzanquet and 2) if members can call into meetings as long as it is properly reflected in the agenda. It was recognized that Mr. Don Harmon has previously been the Chair.
