President Esquivel asked each Trustee and the Superintendent to report any new business:

- Clerk Quintanilla reported on the following:
 - The Leader in Me signs at Encinita are fading and asked Ms. Carreon if she could research replacements
 - Requested a status update on class size reduction at Muscatel and whether the District will visit this topic in the future.
 - Superintendent Enomoto-Perez shared that the interventions the District is working on at Muscatel include moving towards 1:1 chromebooks throughout the summer and the training of additional staff on the iReady program.
 - Assistant Superintendent Lovato added that some of the Muscatel staff
 is piloting the program this summer and are already asking for
 information regarding the incoming 6th graders iReady student data.
 - Requested customer service training for office staff throughout the District and shared a personal experience
 - Assistant Superintendent Lovato shared that this is also a request made by parents which has been included in the LCAP.
 - Superintendent Enomoto-Perez added that the administrators who participated in the recent trainer of trainer Leader in Me 7-Habits workshop came up with a plan and will work in teams to roll the initiative out following an action plan.
 - o Inquired if the schools have a similar door locking system in place during emergencies such as the recent UCLA incident.
 - Assistant Superintendent Lovato advised that there is a mechanism used by classrooms.
 - Superintendent Enomoto-Perez added that the doors have an internal locking mechanism and the District has campuses locked during the day with one-point of entry.
 - o Inquired that it was shared with him that there was an issue at Shuey where their ELD training was cancelled due to the lack of substitutes.
 - Assistant Superintendent Carreon shared that there were some days that had to be cancelled due to too many teachers were out and there were not enough substitutes available. She further shared that the cancelled training was rescheduled and completed before the end of the school year.
 - o Inquired if the Board would be receiving a summary of the Franklin Covey series feedback each participant receives during the training.
 - Superintendent Enomoto-Perez shared that the Speed of Trust workshop includes an assessment which is geared towards the participants.
 - Assistant Superintendent Lovato added that the assessment is an evaluation tool and it's more for the individual to self-reflect.
 - Member Armenta added that the sharing of the assessment is not ethical nor should it be distributed or shared publicly and later shared with the participants that it was shared, as the assessment is answered by each participant in a vulnerable manner.
 - Asked if the District has curriculum for special education, if it is present at all schools; it was shared with him that not all schools have it available nor all schools have it implemented.
 - Director of Special Education and Student Support Services Rock shared that the teachers have been trained in the curriculum available with the exception of a new teacher. She explained that the District has a program that is still in the process of different levels of implementation and training is continuing. The curriculum includes lessons, as a teacher you have to prepare your lesson plans. She further explained that the SELPA classes have curriculum, which includes the adjustment of regular education curriculum.
