STUDY SESSION

1. Presentation on Consolidation of the Rosemead School District – Board of Trustees, Board Elections with the Statewide General Election – Mr. Warren Kinsler, Attorney, Atkinson, Andelson, Loya, Romo, & Ruud

Superintendent Enomoto-Perez introduced Attorney Tiffany Tran from Atkinson, Andelson, Loya, Romo, & Ruud and shared that although the Board agenda for February 2, 2017 was published today, if the Board decides to move forward with changing its election cycle to consolidate with the General Election that the necessary resolutions could be added as an amendment to the agenda tomorrow. Mrs. Tran reviewed the attached presentation data with the Board of Trustees and answered questions. She reviewed the intent of both sample resolutions and provided guidance regarding the next steps based on the Board's consensus to move forward.

2. <u>Enrollment and Marketing Plan Update – Dr. Donald Brann, Consultant/Retired Superintendent</u>

Consultant Dr. Brann provided the following update on the Enrollment and Marketing Plan project. He explained that declining enrollment is caused by a combination of the below factors: gentrification where parents remain in the community with no young children, demographic shifts from Hispanic to Asian - smaller family sizes, decline is being experienced by all surrounding districts not just Rosemead, and school districts are marketing their district, such as Los Angeles Unified School District using bus advertisements and Garvey School District mailing of flyers which results in competition for students. Dr. Brann shared the work he has done thus far in getting to know each unique school and district, programs offered such as The Leader in Me, small class sizes, technology, pre-school, child care, and caring leadership, etc. He complimented the District on the apparent passion of staff and their dedication and the student leadership that is demonstrated at all campuses. He also shared that the close proximity of the district schools to the 10 freeway for commuters and child care are positives many parents value which makes the District very appealing. He added that the schools are safe and clean. Dr. Brann explained his next steps and timeline. He offered to the Board to be available to meet with each Board Member at any time.

It was the Board's consensus to schedule Dr. Brann for a quarterly report on the project.
