# INTERIM SUPERINTENDENT'S REPORT

Interim Superintendent Fang shared that there are many exciting things happening in Rosemead and highlighted some items:

- Thanked everyone for coming out to celebrate and congratulated our Retiree Hilda Ramirez, Classified Employee of the Year Claudia Rivera, and Teacher of the Year Sharon Giambalvo.
- Enjoying my Interim Superintendency and hosting "Java with Jennifer" at each school site
- The STEAM Team named their grant "DREAMS" which stands for Developing Rosemead Engineers, Artists, Mathematicians and Scientists and thanked the DREAMS Team for their dedication to the grant.
- Today during the DELAC/DAC meeting parents were provided with an update regarding the DREAMS STEAM Grant effort and parents shared that they would like to see a STEAM Lab at every school and feel that all students would benefit from a lab at their campus.
- Just received information on the California STEAM Symposium occurring on Sun., October 28 Mon., October 29 in Long Beach. The STEAM Team is interested in attending with a possibility of 10-11 staff members attending.

# **SPECIAL REPORTS AND PRESENTATIONS:**

- Facilities Update Dr. Armida Carreon, Assistant Superintendent, Business Services

  Mrs. Maria Elena Romero, Facilities Consultant and Dr. Armida Carreon, Assistant
  Superintendent, Business Services provided the following update:
  - o Fire alarm at Janson school received a surprise visit from the Fire Chief who was accompanied by trainees. Mrs. Romero shared that the fire alarm system had been operating and we have been in the process of designing and getting approval for a new fire alarm system. The system has been having issues which have been repaired. The Fire Chief stated to Mr. Octavio Serrato that the District needed to have a 24-hour fire watch the system is fully functional. A repairman repaired the system this weekend after the parts were manufactured back east. Mr. Serrato explained to the Fire Chief that the new fire alarm system plans are in the process of receiving DSA. He also shared that the system is outdated and the parts were not available anywhere. The system was fully functional but the Fire Chief didn't like that the panel read "Trouble". Fire watch at Janson has been covered by Octavio, Erin and Ron.
  - o Mrs. Romero explained the pros and cons of installing a proprietary versus a nonproprietary system and how the decision is up to the district. She shared that the team is currently bidding 2 schools Janson & Savannah together for the new fire alarm system.
  - Mrs. Romero answered Board questions and shared that she doesn't recommend to a District to go to bid prior to receiving DSA approval because it is illegal and both the District and Board Members could be personally liable.
  - o 99% completed with the roofing project and are working on the punch lists.
  - o Mrs. Romero shared that the team will start the fire alarms as quickly as possible.

# • Educational Services Updates - Dr. Laurie Baccus, Interim Assistant Superintendent, Educational Services

Interim Superintendent Fang provided the following update:

- Board President Armenta will be contacted for a signature in order to submit the DREAMS STEAM Grant
- o In case the grant is not funded, the Team and parents would like to see a STEAM lab at each campus and the team is willing to help.
- Shared that the CAASSP results were just released a couple days ago and a brief and presentation provided to the Board
- Shared that Monday will be a Professional Development Day and a survey has been provided to teachers for feedback on the NGSS component.
- O The Administrative team is visiting all schools where the principal chooses a focus area. The first one was at Janson and was a fun day spending it seeing kids in action and talking with the students meanwhile observing methods being used. The next visit we are going to a Whittier (Technology Academy), we will be visiting the remaining the rest of the schools in Rosemead.
