person would present imminent risks to the health or safety of attendees, subject to compliance with the requirements set forth in Government Code section 54953(e)(2). AB 361 provisions are set to sunset on December 31, 2024.

Effective January 1, 2023, through December 31, 2025, the Rosemead School District Board of Trustees will adopt new procedures to continue holding public meetings in person and via teleconferencing pursuant to Assembly Bill 2449. AB 2449 was signed into law on September 13, 2022, and authorizes the Rosemead School District to participate in local agency meetings remotely based on the board members' own emergency needs or for other identified just causes if both the individual member and the local legislative body comply with the outlined procedural requirements, which generally include notice, board action to approve requests, and certain board member and public electronic and in-person meeting requirements.

The Board of Trustees values your comments. Pursuant to the Brown Act, Government Code 54954.2, 54954.3, and Education Code 35145.5, the Board cannot take any action or discuss a topic of concern until such time as the matter may appear as an item on a forthcoming agenda. Pursuant to Board Bylaw No. 9323, each individual speaker shall be allowed three (3) minutes to address the Board on each agenda or non-agenda item. The Board shall limit the total time for public input on each item to 20 minutes.

On October 16, 2025, the Rosemead School District Board of Trustees will be available at 7:30 p.m. for a public hearing on the Rosemead Teachers' Association (RTA) initial contract proposal to the Rosemead School District for the 2025-2028 Successor Agreement. The purpose of the hearing is to allow an opportunity for public input. The hearing will conclude 5 minutes after the last public comment, but in no event earlier than 7:40 p.m.

# Rosemead Teachers Association Initial Proposal to the Rosemead School District 2025-2026

Under the Educational Employees Relations Act (EERA), all initial proposals of the Rosemead Teachers Association (RTA) which relate to matters within the scope of representation, must be presented at a public meeting in order to establish and maintain open dialogue and communication in connection with the subjects to be negotiated. The Association expresses interests in the following:

Article 1 Recognition - Add preschool special education teachers as a group represented by RTA.

Article 7 Term of Agreement - Update the years of the term of agreement.

Article 11 Leaves of Absence - RTA would like to establish catastrophic leave donations for unit members who have exhausted all of their leave time. Establish clearly defined hours for unit members using a half-day substitute to ensure the workday is divided evenly.

Article 12 Workday/Work Year - Include previously negotiated language regarding lunch breaks and recess times. To better accommodate more families and their varying schedules, increase the number of minimum days allocated for parent conferences. Additional time at the beginning of the year for classroom preparation and completing mandated online trainings.

Article 13 Class Size - To ensure the greatest impact on student learning, look at lowering class size limits. Additionally, add language for caseloads for special education and ELD teachers.

Article 16 Safety - RTA aims to have clear guidelines, processes, and protections in place for the safety of its members.

Article 18 Economic Agreement - RTA is seeking increases in salary, extra duty compensation, stipends, longevity, and fringe benefits to fairly compensate unit members, reflect the rising cost of living, and address growing health care expenses.

Article 19 Evaluation Procedure and Calendar - Look at the frequency of evaluations and clarify language for third year employees.

On October 16, 2025, the Rosemead School District Board of Trustees will be available at 7:30 p.m. for a public hearing on the Rosemead School District initial contract proposal to the Rosemead Teachers' Association (RTA) for the 2025-2028 Successor Agreement. The purpose of the hearing is to allow an opportunity for public input. The hearing will conclude 5 minutes after the last public comment, but in no event earlier than 7:40 p.m.

### ROSEMEAD SCHOOL DISTRICT INITIAL PROPOSAL TO ROSEMEAD TEACHERS ASSOCIATION (RTA)

#### Subjects included in the District's Proposal

The following list represents the initial subjects of negotiation to be presented by the District to the members of the certificated service represented by RTA:

#### 1. Article XIV: Transfer and Reassignment

The District proposes incorporating additional criteria such as teacher trainings, credentials, and program alignment to ensure that decisions prioritize student success, maintain critical services, and preserve the district's ability to meet diverse educational needs.

#### 2. Appendix B: Extra Assignment Compensation Schedule

The District proposes establishing additional guidance that clearly defines eligibility, processes, and expectations, ensuring fairness, transparency, and consistency for all staff members.

#### 3. Article VIII: Calendar

Review and update the 2025-2026 calendar (including professional development days).

#### 4. Article IX: Salary and Allowances

The District proposes new language concerning compensation to the bargaining unit that complements the goals and objectives of the District education community as articulated in the Local Control and Accountability Plan (LCAP) and respects the dignity and effort of all school employees.

#### 5. Article X: Health and Welfare Benefits

The District proposes new language concerning fringe benefits (salary & health benefits) to the bargaining unit that complements the goals and objectives of the District educational community as articulated in the Local Control and Accountability Plan (LCAP) and respects the dignity and effort of all school employees.

#### 6. Article X: Workday/Work Year

The District proposes to align the instructional day at all schools in order to offer more intervention and enrichment time for students and additional preparation and professional development time for teachers. Mastering core subjects, engaging in enrichment, and receiving targeted support, which can boost academic achievement, are the goals of this proposal. It also gives teachers greater opportunities to deliver high-quality, differentiated instruction and integrate activities like SEL and interventions. This proposal also offers a path to increasing student enrollment and interdistrict transfers into the Rosemead School District.
