Exhibit 1 Matrix for New Business Topics and Follow Up

- Superintendent Ruvalcaba provided the following information updates
 - There are no additional changes to the matrix from the last meeting.
 - Suggested allowing public comment practices to be revised and for the Board to consider the following options:
 - Allow members of the public to submit their request to address the Board and speak using their own voice – with 3 minutes approximately equating to 750 written words.
 - Allow members of the public to continue to submit their public comment via email for it to be read onto the record by the Superintendent's Office.
 - It was the Board's consensus to move forward with offering both options to members of the public.

- Update on the Facilities Master Plan site walkthroughs shared that they were originally scheduled for December and canceled as a result of the strong recommendation from the Department of Public Health that we limit the gathering of people outside of our own household, including limiting activities to essential only. The Superintendent suggested that we postpone the walkthrough until February.
 - It was the Board's consensus to postpone the walkthroughs.
- Clerk Armenta expressed that she would like to receive additional information including
 examples as related to the recent amendments to AB 992 Board Act and Social Media.
 She expressed a concerns and asked to receive further clarification from Legal to ensure
 Trustees know the parameters related to the amendment of the Assembly Bill.
 - After Board discussion, it was the Board consensus to move forward with scheduling a presentation by Mrs. Hsu from OMLO on February 4, 2021, and that any information that is currently available be provided to the Board ahead of time since the amendment is already in effect.
- Clerk Armenta shared that she is glad to hear how beneficial Care Solace services have been to the District and inquired on how the District is advertising the service.
 - Assistant Superintendent Fang shared that the services have been pushed out to staff
 and families through our principals through flyers and that the District can boost
 advertising the service.
- Trustee Quintanilla inquired whether the Board would like to see what type of policy services are offered through SSDA since the Board took action to approve a membership.
 - Superintendent Ruvalcaba shared that he has reached out to local districts and it seems that CSBA is the educational organization where policies are received from and that no one has verified the quality of policies from SSDA.
 - It was the Board's consensus, not to move forward with this inquiry at this time as everyone has a lot on their plate due to the pandemic and that maybe in the future we can look at this when the situation is more stable.
 - Superintendent Ruvalcaba suggested that we add this to the matrix for a future topic. The Board agreed.

DISCUSSION ITEM(S):

1. Encinita Portable Classrooms

Superintendent Ruvalcaba shared that with the work for the Facilities Master Plan the District has worked with its facilities team to ensure all documents, plans, permits, etc. are organized in an orderly fashion for every site including all paperwork related to our portables to ensure they are intact for use. He explained that in preparation for the fire alarm project at Encinita the team found a concern with some portables (Room 28 & 29) concerning DSA approval and use of the portable.

Assistant Superintendent Sullins shared the teams' findings, how it affects the use of the two existing portables, which are 21 years old and do not have structural clearance from DSA. Assistant Superintendent Sullins discussed the options to move forward.

After discussion, it was the Board's consensus to relocate regional classroom program from classroom 28 to classroom 26 with the appropriate necessary upgrades to the space. This relocation and completion of the necessary upgrades will ensure room 26 will have sufficient space to house the specialized equipment, upgraded flooring, and an ADA

compliant double restroom within the classroom, needed to serve the unique needs of our student population. The existing portables (room 28 & 29) can only be used as storage space and not for occupancy by staff or students. See presentation attached.
