## County DPH Updates

- "Past Surge Period" on the horizon
  - More stability
  - Declining rates
  - Test positivity is less than 5%
  - Drop in community transmission
- Vaccination rates are ~80% for ages 12 and older

- Exposure management requirements will continue (testing, quarantining...)
