- Shared that the Los Angeles County School Trustees Association (LACSTA) provided a
 great workshop on the topic of Board dynamics and Board operations. He will seek a
 proposal to bring to the Board at a future meeting.
- Trustee Quintanilla shared that the cost for LACSTA was \$4,000.00.
- Lastly, shared that the Traffic Study survey will be placed on the agenda once the District receives the report from the City, aiming for the June 29 agenda.

Clerk Peña shared the following:

- Expressed excitement about the summer program and inquired whether the District can offer a summer program for the students enrolled in the Mandarin DLI program.
- Inquired whether the District can research a program where staff can monitor student activity on the computers.
 - There was unanimous consensus to move forward with the research.
- Inquired whether there is a way to support the custodians.
- Assistant Superintendent Rios shared that there is a current vacancy at Muscatel and that the District hired a roving substitute to provide additional support to the sites; however, since the vacancy the responsibilities of the roving substitutes have been realigned to cover the vacancy. The District is constantly seeking new substitute custodians to address the shortage; however, it has been very challenging. She added that both Tony Flores and Octavio Serrato assist with opening schools to cover morning absences. Dr. Rios gave kudos to the maintenance & operations and custodian teams for doing the best they can to cover our schools meanwhile we are short-handed by working extra hours. She added that if the District hires an outside agency, this becomes an issue for contracting out staff work.
- Superintendent Ruvalcaba added that although the District is receiving applications for the position and is discovering that the applicants are not qualified. He added that the District office custodian is also utilized as a rover alternating the afternoons at each site throughout the week to provide support.

What is the California Healthy Kids Survey?

The California Healthy Kids Survey (CHKS) is the largest statewide survey of resiliency, protective factors, and risk behaviors in the nation. Across California, the CHKS has led to a better understanding of the relationship between students' health behaviors and academic performance, and is frequently cited by state policymakers and the media as a critical component of school improvement efforts to help guide the development of more effective health, prevention, and youth development

Since 1997 the California Department of Education has funded the CHKS to provide data to assist schools in:

- Fostering safe and supportive school climates, social-emotional competencies and learning engagement
- Preventing youth health risk behaviors and barriers to academic achievement
- Promoting positive youth development, resilience and well-being.

The CalSCHLS system includes:

- the California Healthy Kids Survey (CHKS);
- the California School Staff Survey (CSSS); and
- the California School Parent Survey (CSPS)

All three surveys were developed by WestEd with the help of expert advisory committees of educators, researchers, and practitioners. The staff and parent surveys were added to CHKS to address the needs of districts for data on school working conditions, parent involvement, and enable comparison of staff and parent perspectives to student self-reports. Designed as a flexible data system that meets multiple needs, all three surveys can be customized by combining different modules and adding questions. It is an ideal tool for collecting data on local priorities as part of a Local Control Accountability Plan.

Administration of the Survey

The California Department of Education requires schools and districts to ask students in Grades 5, 7, and 9, 11 to participate in the California Healthy Kids Survey, Rosemend School District administered the survey to students in grades 5. 6, 7 and 6 this year. The survey asks students questions about alcohol, tobacco, and other drug issues, as well as questions about school safety and the learning environment. The survey is anonymous, no names or any other identifying information is connected to the answers except for the name of the school.


