Superintendent Ruvalcaba shared the following updates for the matrix:

- Replacement of pole vault system that based on the feedback received from teachers, the District is moving forward with the conversations with the Principals and teachers. Next steps include receiving a sample from different vendors to compare the differences between two boards.
- Permanent Signage that some permanent signage has already been posted and will continue to be worked on.
- Bullying and Safety that staff has already scheduled the 2 parent forums for Nov. 9th on PBIS and anti-bullying and Nov. 16th on school safety.

 Board Goals - that the Board goals have been updated based on the Board's direction and have added the development of a District assessment tool to the matrix.

Trustee Quintanilla shared the following:

- Inquired regard the crosswalks requested Board consensus to request an
 evaluation or survey for Savannah and Encinita to see if an additional crossing
 guard is needed. For Savannah, the evaluation request is specific to the corner
 of Marshall St. and Rio Hondo and for Encinita Lower Azusa dn Encinita.
- Superintendent Ruvalcaba shared that the District would need to make the
 request from the City of Rosemead to conduct a survey at those two
 locations and the city would make the request to the third party
 vendor. Additionally, requesting the historical information of when the
 schools were last surveyed and if each location is surveyed annually or the
 frequency.
 - It was the Board's Consensus to move forward with the requests to the City.
 - Additionally, President Armenta requested for our community to be very careful with the safety of both our students and crossing guards.
- Requested an update on the Sheriffs alternating their presence at each campus.
- Superintendent Ruvalcaba shared that Deputy Farley is monitoring the locations and that motorcycle patrols are seen regularly around the schools.
- Requested for the status of the evaluation software to be used for the Superintendent and Cabinet.
- Superintendent Ruvalcaba shared that staff did not receive Board consensus to move forward with researching the tool and provided his feedback regarding the tool. He shared that the current tool that is utilized is extremely useful as the District is able to tailor it to the needs of our district and align to our goals. He did not recommend moving forward with researching the tool.
 - It was the Board's consensus, not to proceed with researching the tool.

Good evening, my name is Sandra Almaraz, I am a 6th grade teacher at Shuey and ERP co-chair for RTA. ERP is the employee relations committee that tries to resolve concerns that are brought to us. I am speaking this evening regarding an issue that came to ERP.

Substitute teachers as you know are in short supply. Just last week, we had to split up a 6th grade class twice at Shuey because we didn't have enough substitute teachers in the district. This continues to be an ongoing problem in the district.

Furthermore, our day to day substitute rate and our long term substitute rate is the same rate of \$175 per day. This is problematic. Our long term substitutes are doing the same job as a teacher (Back to School Night, parent conferences, planning, report cards, etc...) and earning the same rate as a substitute who just goes into the classroom for one day. This is not a negotiations item because substitute teachers are not represented by RTA. However, I want to tell you how it does affect teachers and students. If we do not do something about this issue, we will not have long term substitute teachers. I would not want a day to day sub in my classroom if I were to have to go out for any type of leave of absence. This is not good for students. Children need consistency! Children need someone who they can make connections with, not someone different every day. We need to think of not only the academic needs, but the social emotional needs of all of our children.

This is also not good for teachers. This would place an extra work load on grade level teachers. We have amazing colleagues who always step up to help one another; however, It is not fair on teachers to have to carry that burden to keep two classes going. This has been the case in many instances.

We did comparisons of neighboring districts sub pay. West Covina is paying \$200 daily and \$285 long - term rate. Garvey is paying \$225 daily and \$250 long - term rate. Temple City is \$175 a day and \$200 long - term rate. Pasadena is paying \$200 daily and \$250 long term rate.

We need to be more competitive and attract substitutes to our district. We need the board to be aware of this situation so it can be addressed and taken care of. We would appreciate your help. Thank you for your time.
